Endo utilizes these financial measures because (i) they are used by Endo, along with financial measures in accordance with GAAP, to evaluate Endo's operating performance; (ii) Endo believes that they will be used by certain investors to measure Endo's operating results; (iii) the Compensation & Human Capital Committee of Endo's Board of Directors uses adjusted diluted net income per share from continuing operations and adjusted EBITDA, or measures derived from such, in assessing the performance and compensation of substantially all of Endo's employees, including executive officers. Endo believes that presenting these non-GAAP measures provides useful information about Endo's performance across reporting periods on a consistent basis by excluding certain items, which may be favorable or unfavorable, pursuant to certain specified procedures. Endo's definition of these non-GAAP measures may differ from similarly titled measures used by others. 

- Specialty Products revenues decreased primarily due to SUPPRELIN® LA driven by lower average net selling price as a result of business mix.
- XIAFLEX® revenues decrease driven by inventory destocking. 1Q'23 demand growth in-line with internal expectation, reflecting steady progress in adapting to continued market dynamics and ongoing 3<sup>rd</sup>-party specialty pharmacy provider transition.
- Established Products portfolio declined due to competitive pressures.




Decline in Sterile Injectables primarily driven by decreased VASOSTRICT® revenues due to lower price and market share resulting from generic competition and lower overall market volumes.



## Q1 2023 Performance (Reported Revenues in \$ millions)


#### **Generic Pharmaceuticals**





- Increase primarily attributable to revenues from dexlansoprazole, the generic version of Dexilant® launched during 4Q22, and from varenicline, the first FDA-approved generic version of Chantix® launched during 3Q21, partially offset by competitive pressure on certain generic products
- A generic varenicline competitor entered the market during 1Q23; additional competitors are anticipated in '23

## Pipeline Highlights

#### **Branded Business:**

#### > XIAFLEX®

#### Plantar Fibromatosis:

Phase 2 study achieved objective to identify optimal Phase 3 path. A large sub-population met the primary endpoint and majority of all secondary & exploratory endpoints. Phase 3 initiation expected later in '23.

#### Plantar Fasciitis:

Launched proof of concept clinical study during 4Q'22. Top-line results expected late '23.

#### > TLC599:

Phase 3 study participants showed improvements consistent with Phase 2 but not statistically significant to placebo. Evaluating next steps with development partner TLC.

#### Sterile Injectable & Generic Businesses:

#### > New Product Launches

Launched 6 products YTD 2023, plan to launch ~10 products in 2023

#### Regulatory Filings:

~25 pending filings, >40% are Sterile Injectables

#### New Product Pipeline:

~40 projects in development; >90% are Sterile Injectables, with ~75% ready-to-use or other differentiated products

#### **Key Points:**

Endo's first-quarter 2023 results exceeded the expectations assumed in the February long-term plan previously disclosed by the company.

Updated FY'23 financial expectations contemplate a range of potential outcomes reflecting uncertainties in key assumptions for:

- Timing of varenicline and dexlansoprazole competitive entrants
- · Recognition of the Novavax settlement

Endo does not currently anticipate a material impact to its previously provided long-term financial outlook beyond 2023.
