As of December 31, 2018, Mr. Robbins may be deemed the beneficial owner of 4,486,336 Shares. This amount consists of the 4,478,336 Shares beneficially owned by Glenview Capital Management plus 8,000 Shares held in certain custodial accounts controlled by Mr. Robbins.
